

ORDINANCE NO. 88-22

AN ORDINANCE AMENDING SECTIONS 155.01 (b), (c), AND (d) OF THE CODIFIED ORDINANCES OF THE CITY OF ASHLAND, OHIO PROVIDING FOR THE SALARIES OF CERTAIN ELECTED OFFICIALS OF THE CITY OF ASHLAND; AND REPEALING EXISINTING SECTIONS 155.01 (b), (c) AND (d) OF SAID CODIFIED ORDINANCES.

Whereas, THIS Council desires to make new provisions for the salaries of certain elected officials in order to provide for the continued efficient and effective operation of said elective offices of the City of Ashland, Ohio; now therefore,

BE IT ORDAINED by the Council of the City of Ashland, State of Ohio, 5 members thereto concurring:

Section 1. That Sections 155.01 (b), (c) and (d) of the Codified Ordinances of the City of Ashland, Ohio, providing for the salaries of certain elected officials of said City, be and the same are hereby amended to read as follows:

155.01 ELECTED OFFICIALS: SALARIES, BONDS, ETC.

- a) Effective January 1, 2024, the Director of Finance and Public Record for the City of Ashland, Ohio, shall be paid the following payable bi-weekly. Furthermore the Director of Finance shall be bonded in the sum amount of \$50,000.00. The annual salary for the Director of Finance and Public Record shall be as follows:

2024 - \$85,000.00  
2025 - \$86,700.00  
2026 - \$88,434.00  
2027 - \$90,202.00

- b) Effective January 1, 2024, the Director of Law for the City of Ashland, Ohio, shall be paid the following payable bi-weekly. Furthermore the Director of Law shall be bonded in the sum amount of \$50,000.00. The annual salary for the Director of Law shall be as follows:

2024 - \$90,000.00  
2025 - \$91,800.00  
2026 - \$93,636.00  
2027 - \$95,509.00

c) Effective January 1, 2024, the Members of the Council elected from Ward One and At-Large for the City of Ashland, Ohio, shall be paid the following payable bi-weekly. Furthermore each said Members of Council shall be bonded in the sum of \$50,000.00. The annual salary for these Members of the Council shall be as follows:

2024 - \$9,000.00  
2025 - \$9,180.00  
2026 - \$9,364.00  
2027 - \$9,551.00

All Increases shall be applied as of January 1 of each respective year.



Section 2. That the salaries of said elected officials of the City of Ashland, Ohio, as provided for in existing Sections 155.01 (b), (c) and (d) shall continue in full force and effect until the provisions of the amended Sections 155.01 (b), (c) and (d) become applicable to each elective office, respectively.

Section 3. That existing Sections 155.01 (b), (c) and (d) of the Codified Ordinances of the City of Ashland, Ohio, be and the same are hereby repealed, subject to the provisions of Section 2 hereof.

Section 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
