

Resolution : 1-22

A Resolution authorizing submittal of the application dated January 15, 2022 for a Public Transportation Capital Grant under the Ohio Department of Transportation's general authority to make such Grants; and declaring an emergency.

WHEREAS, The provision and improvement of public transportation facilities, equipment, and services is essential to the development of safe, efficient, functional public transportation; and

WHEREAS, The Ohio Department of Transportation has the authority to make such Grants and makes funds available to offset eligible capital costs required for providing and improving public transportation facilities, rolling stock, equipment, and services; and

WHEREAS, Grants for said funds will impose certain obligations upon the recipient.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BOARD OF THE CITY OF ASHLAND, 4 MEMBERS THERETO CONCURRING :

Section 1. That the Governing Board of the City of Ashland officially endorses and fully supports this application and project.

Section 2. That an application be made to the Division of Planning, Office of Transit, Department of Transportation, State of Ohio (The Department), for a financial assistance grant under the Ohio Department of Transportation's general authority to make such Grants, for the purpose of offsetting eligible public transportation capital costs of the City of Ashland. The applicant certifies a capacity to provide a 20% local match for the state funding and specific identification of those sources.

Section 3. That Mayor of the City of Ashland is hereby authorized and directed to sign and submit such application on behalf of the City of Ashland.


Section 4. That the Mayor of the City of Ashland is authorized to furnish such additional information as may be required by the Department in connection with the aforesaid application for said Grant.

Section 5. That Mayor of the City of Ashland is hereby authorized and directed to execute on behalf of the City of Ashland the Grant Agreement or subsequent Grant Agreement Amendments resulting from aforesaid application.




