

ORDINANCE NO. 65-23

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A CONTRACT FOR THE PURCHASE OF FOUR VEHICLES WITH APPURTENANCES FOR THE POLICE DIVISION OF THE CITY OF ASHLAND, OHIO; AND DECLARING AN EMERGENCY.

WHEREAS, this Council deems it necessary and advisable to immediately purchase four vehicles with appurtenances for the Police Division of the City of Ashland, Ohio; and

WHEREAS, this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, property, health, safety and welfare and for the further reason that the four vehicles with appurtenances herein specified are immediately needed in order to provide for the continued efficient and effective operation of the Division of Police of said City of Ashland, Ohio, now therefore,

BE IT ORDAINED by the Council of the City of Ashland, State of Ohio, 5 members thereto concurring:

SECTION 1. That the Mayor be, and is hereby, authorized and directed to enter into a contract for the purchase of four vehicles with appurtenances for the Police Division of the City of Ashland, Ohio, obviating formal advertising and bidding, due to the purchase price of the vehicles being below the state cooperative purchasing bid pricing.


Four (4), 2023 Dodge Durango Police AWD vehicles with appurtenances not to exceed a total of \$325,000.


SECTION 2. That the money for said equipment shall be paid out of the **267 Police 60 Fund** in a method as determined by the Director of Finance.

SECTION 3. That for the reason that the equipment herein specified is immediately needed in order to provide for the continued efficient and effective operation of the Division of Police of the City of Ashland, this Ordinance is hereby declared to be an emergency measure immediately needed for the preservation of the public peace, property, health, safety and welfare of said City of Ashland, Ohio.


